1.7 TC39 - ECMAScript

Activity report: TC39/15/047.

Chairman: Mr. John Neumann (Microsoft, Mozilla, Google), Vice Chair: Vacant.

Mr. Sebestyen reported about the work of TC39:

Work on the 6th Edition of ECMAScript (ECMA-262) was completed and has been approved by the GA in June 2015. Same for the 2nd Edition of ECMA-402. Publication of ES6 has resulted in positive user response, but due to the significantly added new materials in ES6 we are also getting several "bug" reports. TC39 uses the Bugzilla tool to track those. Under "bugs" all different type of entries are meant. Among them the real technical errors that requires immediate action are only a very few. All these "bugs" are now collected and in a new Edition (ES7) this will be corrected. ISO is waiting for the fast-track, but they want Ecma to wait until the bugs are corrected. JSON is stable, fast-track to JTC 1 will come. Cross reference to a just started ETF JSON standard has to be done, when that is available. We keep liaison contacts with IETF on that issue.

Mr. Sebestyen said that the status of the TC39 fast-tracks will be discussed with JTC 1 officials in a separate meeting at the JTC 1 Plenary meeting in Beijing the following week.

Standards & Technical Reports to be submitted to the General Assembly and fast-track processing in JTC 1: None.

Future Plans: Work in TC39 will continue to focus on development of the ECMA-262 and related specifications. Work has continued on specifying an additional Edition ES7 of the language. Work also continue on the Test system known as TEST-262. This will also include the ECMA-402 tests. ES7 is planned as "ECMAScript 2016" to be approved in June 2016.

Membership: Membership is still growing. TC39 has constantly about 30-35 meeting participants. We are also getting new Ecma members. Some of them are in the pipeline to submit membership application.
