## 2 Executive summary

Work on the new Edition of ECMAScript was completed and is being sent for GA Approval. A new Edition of ECMA-402 is also in progress now with expected completion of June also 2014. Further work on JSON is under consideration but not concretely planned. Our first liaison with IETF occurred with attendance at our last meeting of the IETF appointed liaison to TC39.

## 4 Future outlook

#### 4.1 Future Plans

Work in TC39 will continue to focus on development of the ECMA-262 and related specifications. Work has already started on specifying an additional Edition (7) of the language. Work will continue on the Test system known as TEST-262. This will also include the ECMA-402 tests. A second version of ECMA-402 is already under development.

### 4.2 Membership

Membership has levelled off since the last report and Netflix is latest new member to join and they abstained on all votes this week (votes were 6-0-0 and 6-0-1). It is also possible that some existing members who have been active in TC39 in the past will intensify their activity on the committee, such as Apple or Adobe.

### 4.3 Plans for growth

This committee is self sustaining. We will not actively look for new members but will encourage companies wanting to participate but hesitating due to the RFTG rules put into place within TC39. Our last meeting was held in Europe in March and this may bring some European companies to show some interest in our work.

TC39 is considering to have one update of ECMAScript per year. No impact is seen in the market place.
